# Summary This paper invites the SVG to approve two General Change Requests and note 17 Fast Track Change Requests, for implementation in Version 338 of Market Domain Data (MDD) with a go-live date of 16 August 2023.

# 1. Introduction

1.1 Updates to Market Domain Data (MDD) are made through monthly releases. Elexon progresses MDD changes in accordance with <u>BSC Procedure (BSCP) 509 'Changes to Market Domain Data'</u>.

#### **General Change Request process**

1.2 BSCP509 requires that General MDD Change Requests undergo validation by Elexon, and impact assessment by the Supplier Volume Allocation Agent (SVAA) and Market Participants, before being presented to the SVG for decision. Unmetered Supplies (UMS) Charge Codes are initially reviewed by the UMS User Group (UMSUG) in accordance with <u>BSCP520 'Unmetered Supplies'</u>, and also go out for Market Participant impact assessment before being presented to the SVG. We include all comments received from the impact assessment in this paper to assist the decision making of the SVG.

#### Fast Track Change Request process

- 1.3 BSCP509 contains the Fast Track process for housekeeping changes and new participant registrations, which require Elexon validation and SVAA impact assessment. However, BSCP509 does not require Fast Track changes to be issued for Market Participant impact assessment or to be approved by the SVG. This means there is a separate deadline which is later than that for General Change Requests. Therefore, Fast Track Change Requests are presented to the SVG for information only.
- 1.4 New Party Agents and existing Licensed Distribution System Operators (LDSOs) registering in a GSP Group must have their Qualification approved by the Performance Assurance Board (PAB) before registering in MDD. However, they can submit Fast Track Change Requests before the PAB meeting for the next MDD Version to go live after the PAB has made its decision. Should the PAB not approve the Qualification application, Elexon will refuse the MDD Change Request. New Suppliers and new LDSOs do not require PAB approval of their Qualification before registering in MDD, and new Suppliers need not have obtained their Supply Licence.

#### 2. BAU Changes for MDD Version 338

2.1 This paper includes two General MDD changes and 17 Fast Track MDD changes to be incorporated into MDD Version 338 with a go-live date of 16 August 2023.

# 3. Technical Product Deliverables (TPDs)

- 3.1 Following the disillusion of the Profiling Expert Group (PEG) last year, the review of the Settlement profiles TPDs are now undertaken by Subject Matter Experts (SMEs) within Elexon. These SMEs then recommend to the SVG whether these new TPDs should be approved for use in Settlement.
- 3.2 The review process for the TPDs has been the same as previous years, whereby Elexon checks for formats and completeness and conducts an initial qualitative review. The SMEs then discuss the findings of this review before making a recommendation to the SVG.
- 3.3 The checks and reviews of the profiles to be used in Settlement for the Autumn/Winter 2023/24 BSC Seasons were completed by 10 July 2023. The new TPDs have passed all tests on content and format, and Appendix 2 provides a copy of the complete checklist.
- 3.4 The new TPDs are made up of:
  - Regression data for the Autumn and Winter BSC Seasons, based on a pooled set of the latest three years' data (2020/21, 2021/22 and 2022/23); and
  - Recalculated Group Average Annual Consumption (GAAC) data for use in the Autumn and Winter Seasons of the current BSC Year.
- 3.5 As usual, Spring, Summer and High Summer profiling data has not been updated in this set of TPDs.
- 3.6 At its meeting on 12 July 2023, the SMEs within Elexon agreed that these TPDs should be used for the next set of profiles. As such, Elexon recommends that the SVG approves these TPDs for use in Settlement for Autumn/Winter 2023/24.

# 4. **Recommendations**

- 4.1 We invite you to:
  - a) **APPROVE** two General BAU Change Requests for implementation in MDD 338 with a go-live date of 16 August 2023;
  - b) **NOTE** 17 Fast Track Change Requests for implementation in MDD 338 with a go-live date of 16 August 2023; and
  - c) **APPROVE** the Autumn/Winter 2023/24 TPDs for use in Settlement for the remainder of the current BSC Year.
