Open session – Decision Papers

1. MDD Change Requests for Version 340– (SVG272/01)

- 1.1 This paper invited the SVG to approve 12 General Change Requests and note eight Fast Track Change Requests, for implementation in Version 340 of Market Domain Data (MDD) with a go-live date of 18 October 2023.
- 1.2 The SVG:
 - a) **APPROVED** 12 General BAU Change Requests for implementation in MDD 340 with a go-live date of 18 October 2023; and
 - b) **NOTED** eight Fast Track Change Requests for implementation in MDD 340 with a go-live date of 18 October 2023.

2. Assessment Report: CP1582 'Remove MA from BSCP520 3.6.2.3' (SVG272/02)

- 6.1 The Unmetered Supplies User Group (UMSUG) recommended that the SVG approves the Interact City and Ki 3.0 Central Management Systems (CMS) for use in Settlement.

 - b) APPROVED Signify's Interact City CMS for use in Settlement from 3 October 2023; and
