No Access

- >> 13% of visits in the last 12 months resulted in no access.
- >> 6% of the no access figure is due to no-one being available to provide access because the premises are closed and unoccupied.

Cat 1 Non-Compliance

- All outstanding NCs are being discussed with the relevant parties which has resulted in only 11 outstanding CAT 1s this quarter.
- >> The average age of the CAT 1 NCs is currently 24 days compared to 105 days last quarter.





No Access Graph By Supplier - 4












This graph shows how many non-compliances have been raised on average per visit for each quarter.








