OPEN SESSION – INFORMATION PAPERS

1.1 **UMS Material Error Monitoring Q2 2022 Report – (UMSUG137/01)**

1.2 This paper provided the Unmetered Supplies User group (UMSUG) with a view of the latest UMS Material Error monitoring (MEM) data from Q2 2022.

1.3 The UMSUG:

a) **NOTED** the latest updates to the UMS MEM Report.

OPEN SESSION – DECISION PAPERS

2. **UMS Queries Log – (UMSUG137/02)**

2.1 This paper provided details of contentious Unmetered Supplies (UMS) topics that have been addressed by the UMSUG. The aim of the UMS queries log is to understand the details of any contentious applications or topics, the UMSUG's responses and the outcome from Elexon. This can then be used as a knowledge base for both Elexon and the UMSUG for future queries of a similar nature.

2.2 The UMSUG:

a) **APPROVED** the latest updates to the UMSUG Queries Log.

3. **Generic LED decimals under 1W – (UMSUG137/03))**

3.1 This paper provided details of the proposed solution for decimal ratings for Generic LED Charge Codes that are less than 1 watt. The aim of the paper is to propose changes to the Operational Information Document (OID). If recommended, the changes will be implemented in Version 26.0 of the OID and Version 4.0 of the Generic LED Guidance Documents (Customer and Manufacturer).

3.2 The UMSUG:

a) **COMMENTED** on the proposed Changes; and

b) **AGREED** next steps for drafting and approving red-lining to the OID.

4. Charge Codes for vehicle activated signs– (UMSUG137/04)

- 4.1 This paper provided details on the proposed solution for a test methodology for vehicle activated signs. The aim of the paper was to request changes are made to the Operational Information Document (OID) to clarify the measurement requirements and data to be presented.
- 4.2 The UMSUG:
 - a) **DISCUSSED** the proposed solution; and
 - b) **AGREED** to review an amended solution at the December UMSUG.

5. Meter Administrator Validation Process; The Need for a Standard Approach – (UMSUG137/05)

- 5.1 This paper highlighted the need for a standardised approach to the validation process of summary files. The aim of the paper was to agree the need to mandate control charge codes in the summary inventory file and propose changes are made to BSCP520 and the Operational Information Document (OID).
- 5.2 The UMSUG:
 - a) **DISCUSSED** the need for a definite validation specification; and
 - b) **AGREED** to continue discussions ex-committee.

6. Discrepancy in Settlement Period – (UMSUG137/06)

- 6.1 This paper called for discussion surrounding discrepancies within a new change in BSCP520, regarding the settlement periods for retrospectively issuing summaries. The aim of the paper was to discuss this discrepancy and propose a solution to the benefit of all parties.
- 6.2 The UMSUG:
 - a) **RECOMMENDED** no changes were required; and
 - b) **PROVIDED** clarification on how to accommodate the 14 month retrospective change.
