Market Domain Data (MDD) Version 306 Issues

There have been some data issues affecting MDD Version 306. These issues are separate to the Clock Interval issue that was highlighted in MDD Circular 00724.

- 1) The Average Fraction of Yearly Consumption (AFYC) value 0.000000 was omitted from MDD Version 306 for SSC 0591, TPR 00002. To successfully load the D0269 file, Non-HH Data Aggregator's (NHHDA's) need to manually enter this value into the D0269 by inputting 'AFD|0.000000|00002' as demonstrated in the screenshot below.

- 2) It is illogical to have an AFYC value of 0, which is currently the case for SSC 0593 TPR 00041 and will be for SSC 0591 TPR 00002, once the AFYC is manually added. As the TPRs add up to 1, they passed validation.

Elexon will update these AFYC values in the February MDD Version 307 publish. Please do not use SSC 0591 and SSC 0593 until 17 February 2021.

- 3) An MDD archiving exercise was completed in MDD Version 224 (CR M2283) with a go-live date of 21 January 2015. SSC 0438, 0471 and 0068 were raised in MDD Version 306. These SSCs existed in MDD prior to the archive and these records may still exist in your systems, if they were not removed as a result of CR M2283. This has caused issues for NHHDA's loading the D0269, as some of the archived records remained in their system. This issue will not impact your system if these updates have already been made.
